

25 YEAR LIMITED WARRANTY

CorrectDeck Decking, when properly installed and maintained according to Correct Building Products published installation and care instructions, is warranted for a period of twenty-five (25) years from the date of installation against rot, decay, splitting, checking, splintering or termite damage under normal conditions of decking use and exposure. Each purchaser of a CorrectDeck Deck Product is solely responsible for determining the effectiveness, suitability and safety of any particular use or application of the product. Building code regulations vary from area to area. Each CorrectDeck purchaser should consult local building and safety codes for specific requirements. The Warranty provided herein is expressly conditioned upon the use of the product in connection with a residential structure and its installation in accordance with Manufacturer's written guidelines.

Correct Building Products LLC shall have no liability for defects or damage resulting from (A) installation directly on top of or attached to a concrete slab, installation directly on the ground, installation directly on top of other decking, or any installation which precludes proper ventilation above, below, and to the side; (B) lack of proper 1/8" side to side gapping for drainage, cleaning and ventilation (C) mildew growth, extractive bleeding, water rings, food, organic, pet, or paint stains (D) settlement, shrinkage, or distortion of the substructure, (E) decks which are not properly sloped for drainage, or (F) nonapproved surface treatments applied to the deck.

Decking should be kept covered and out of the rain until ready to install. Rainwater which would not stain a finished deck will leave stains when the boards are stacked atop each other prior to installation. Many stains may be easily removed with OxiDeck, available from Correct Building Products.

Correct Building Products does not warrant against fade or color change. All colors will fade a minimum of 10%. Correct Building Products shall have no liability for the cost of removing or staining faded decking

If for any reason you believe the decking is defective DO NOT INSTALL. Contact your dealer. Correct Building Products is not responsible for claims arising from installation of visibly defective product.

MILDEW IS NOT A MANUFACTURING DEFECTS AND IS NOT COVERED BY THIS WARRANTY NOR ANY IMPLIED WARRANTY.

WE CANNOT PREDICT NOR PREVENT MILDEW. You can decrease, but not prevent, the risk of mildew by keeping decking dry before installation, gapping the deck properly, clearing away leaves, pet waste, etc., and by washing the deck with a bleach/water solution.

Manufacturer's liability under this Warranty is limited solely and exclusively to replacement of defective CorrectDeck Deck Product, and in no event shall Manufacturer be liable for labor, installation, reinstallation, freight, taxes or any other charge related to defective product. Manufacturer shall not be liable for any indirect, incidental, punitive, consequential, exemplary or other damages of any kind whatsoever, whether any such claim is based upon theories of contract, warranty, negligence, tort, strict liability or otherwise. In any dispute over the performance of the product, the purchaser shall have the burden of proof that the product was installed, finished and maintained in accordance with the Manufacturer's applicable instructions. To file a claim under this Warranty, original purchaser or subsequent owner must send proof of purchase, a picture of the defective product and a written description to Correct Building Products, LLC, 15 Morin St, Biddeford, ME 04005. Manufacturer reserves the right to investigate any claim hereunder. Upon verification of a claim, Manufacturer shall arrange for the delivery of replacement product.

This Warranty may not be altered or amended except in a written instrument signed by Manufacturer and CorrectDeck purchaser or subsequent owner. No dealer or other person or entity is authorized by the Manufacturer to make statements or representations regarding the performance of CorrectDeck Deck Products except as contained in this Warranty, and the Manufacturer shall not be bound by any such statements other than those contained herein.

THE FOREGOING WARRANTY IS EXCLUSIVE AND IN LIEU OF ANY AND ALL OTHER APPLICABLE WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

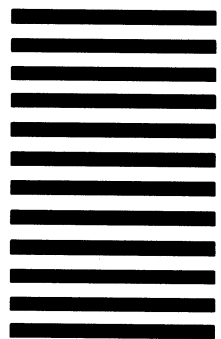
